


**DECISION UNDER DELEGATED AUTHORITY ON AN
APPLICATION BY SKYCITY AUCKLAND LIMITED FOR APPROVAL
OF CONSTRUCTION AND DESIGN CHANGES TO LEVEL 3
AT THE AUCKLAND CASINO**

Date of Decision: 4 October 2010

- 1 On 30 September 2010, SKYCITY Auckland Limited ("**SCAL**") applied, pursuant to conditions 6 and 7 of its venue licence, for approval of construction and design changes to level 3 of the casino. The changes involve building two screens to block two window bays facing onto Hobson Street, re-carpeting the area, replacing some of the wall fabric and installing a privacy screen in the area denoted on the **attached** plan.
- 2 The application raises no issues the Commission needs to consider. Accordingly the application is approved by the Executive Director under delegated authority, pursuant to condition 7 of SCAL's venue licence.



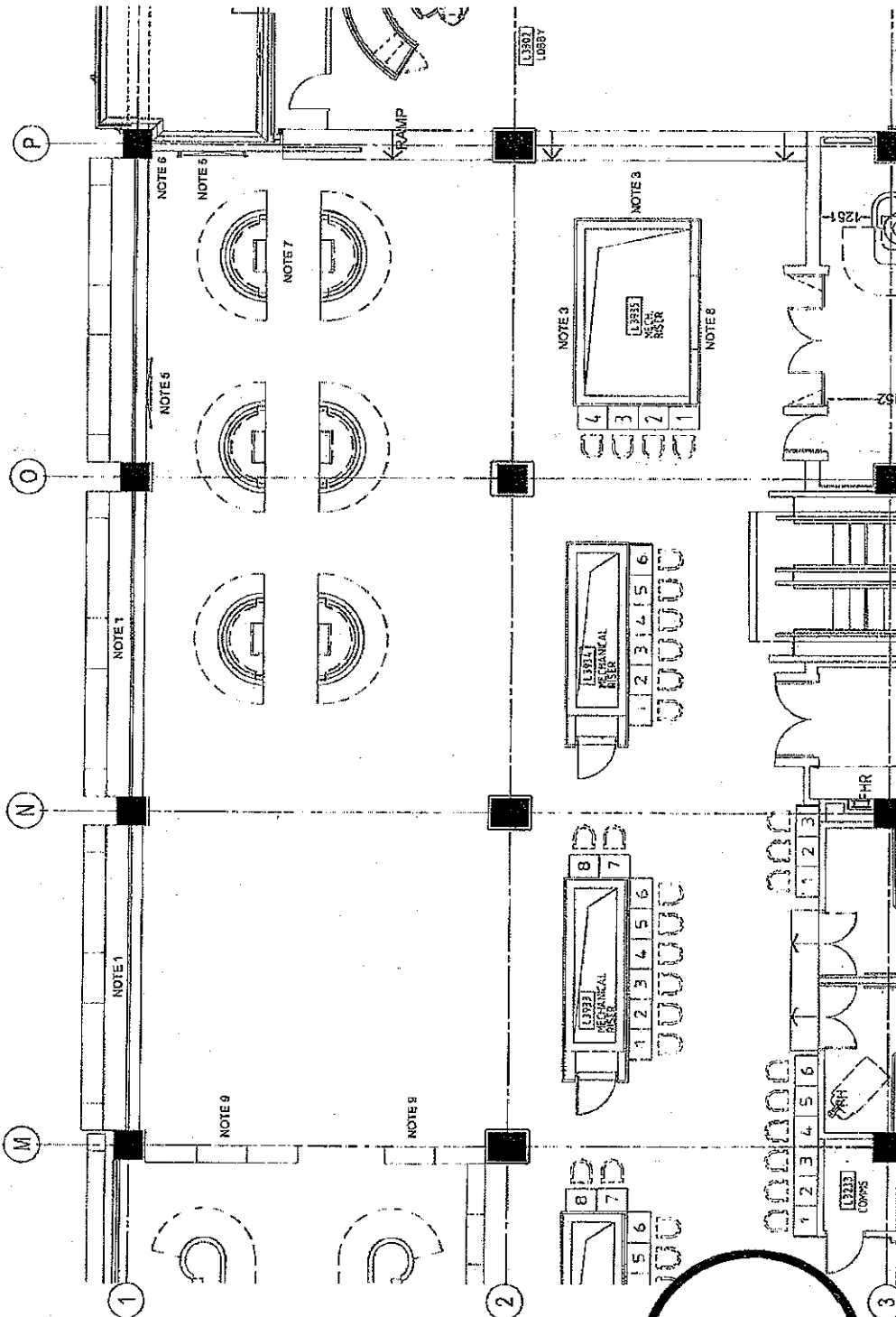

4. NEW CARPET THROUGHOUT TO MATCH EXISTING BAR 21 CARPET.
5. 2 FLAT SCREEN TV'S TO BE REMOVED. 2 FLAT SCREEN TV'S TO REMAIN.
6. FLOOR MOUNTED A/C'S AND POWER OUTLETS TO BE REMOVED AND BASE GOOD.
7. RING BACKPACK TABLES AND ASSOCIATED POWER AND DATA OUTLETS TO BE INSTALLED AS SHOWN (TO BE PROVIDED BY OTHERS).
8. DECORATIVE PADDING AROUND RISER TO BE REPLACED WITH SINGULAR WALL FABRIC AS BAR 21.
9. RELOCATE MOBILE UNITS AND INSTALL FLOOR MOUNTED A/C'S TO MATCH EXISTING FROM FINISHED FLOORING LEVEL.
