

**DECISION UNDER DELEGATED AUTHORITY ON AN APPLICATION
BY SKYCITY CASINO MANAGEMENT LIMITED FOR APPROVAL
OF NEW FLOOR PLANS FOR THE AUCKLAND CASINO**


Date of Decision: 13 December 2010

1. On 9 December 2010, SKYCITY Casino Management Limited ("**SCML**") applied, pursuant to condition 11 of its operator's licence for the Auckland casino, for approval of three new floor plans, "Platinum Stage 3 Temporary", "Platinum Stage 4 Temporary" and "Platinum Stage 5 Temporary".
2. The Commission has previously approved floor plan "Platinum Stage 2 Temporary Revised", but SCML needs to deploy further temporary plans in the Platinum Room as it continues its renovation in that area. All three plans provide for the relocation of gaming machines within the Platinum Room.
3. The application raises no issues the Commission needs to consider. Accordingly the application is approved by the Chief Gambling Commissioner and the Executive Director under delegated authority pursuant to condition 11 of SCML's operator's licence. Floor plans "Platinum Stage 3 Temporary", "Platinum Stage 4 Temporary" and "Platinum Stage 5 Temporary" (**attached**) are approved.
4. Floor plan "Platinum Stage 2 Temporary Revised" ceases to be valid once SCML is fully reliant on "Platinum Stage 3 Temporary". Floor plan "Platinum Stage 3 Temporary" ceases to be valid once SCML is fully reliant on "Platinum Stage 4 Temporary". Floor plan "Platinum Stage 4 Temporary" ceases to be valid once SCML is fully reliant on "Platinum Stage 5 Temporary".

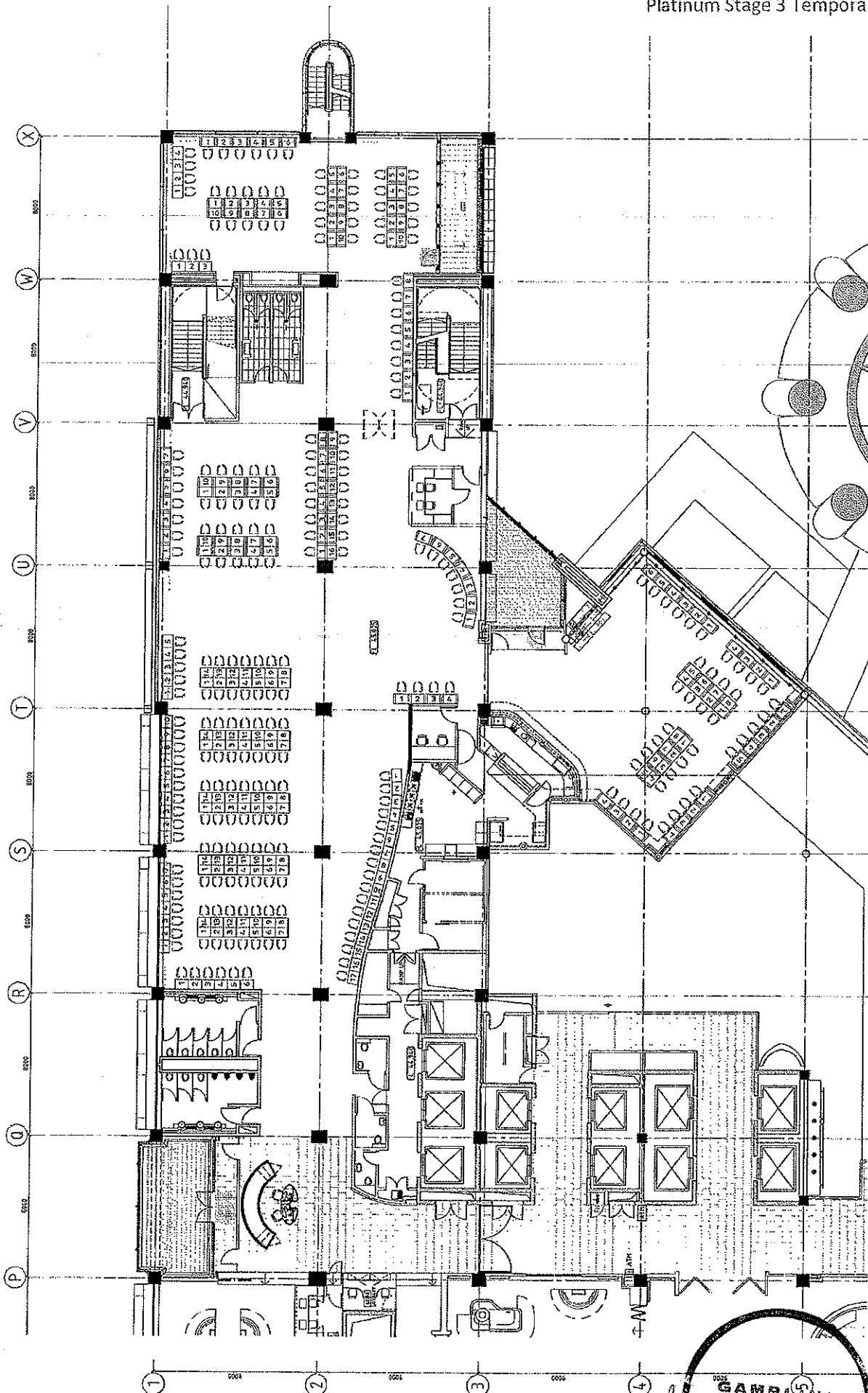


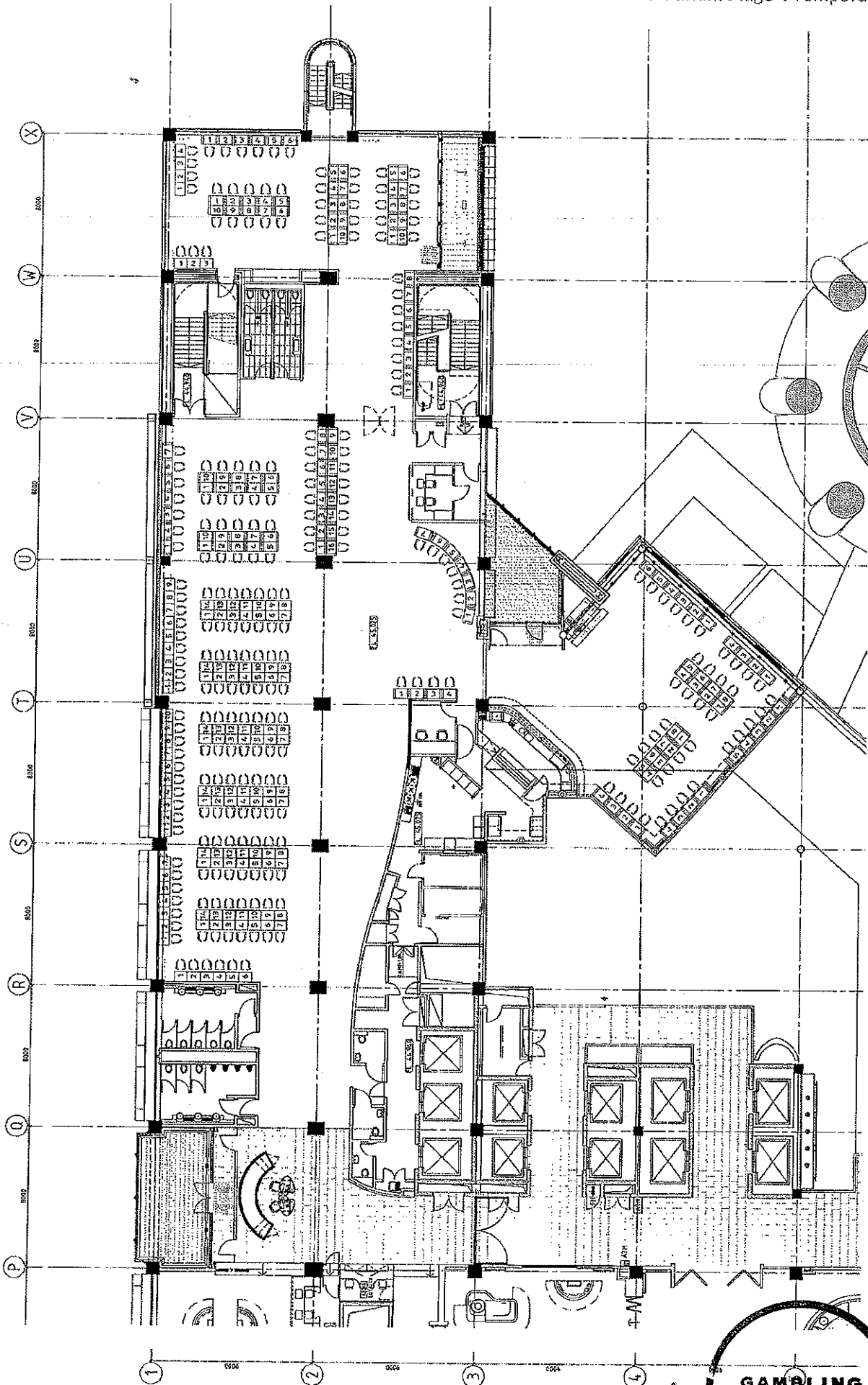
