


**DECISION UNDER DELEGATED AUTHORITY ON AN APPLICATION
BY SKYCITY CASINO MANAGEMENT LIMITED FOR APPROVAL OF
A NEW FLOOR PLAN FOR THE AUCKLAND CASINO**

Date of Decision: 16th September 2011

1. On 16 September 2011, SKYCITY Casino Management Limited ("**SCML**") applied, pursuant to condition 11 of its operator's licence for the Auckland casino, for approval of a temporary floor plan, "Temporary September 2011 (x)".
2. SCML seeks approval of a floor plan which provides for an additional Black Jack game in salon 88 (a VIP salon on the south side of level 5).
3. The application raises no issues the Commission needs to consider. Accordingly plan "Temporary September 2011 (x)" is approved by the Chief Gambling Commissioner and the Executive Director under delegated authority pursuant to condition 11 of SCML's operator's licence. The plan is **attached**.



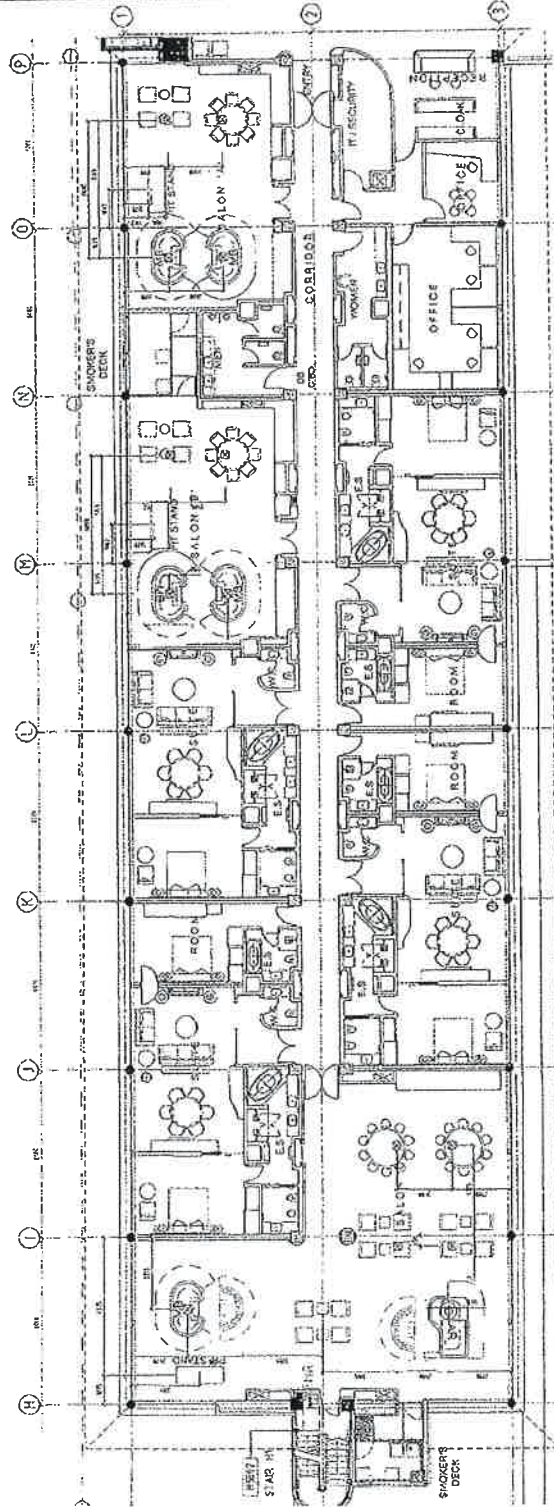
