

1. On 18 October 2011, SKYCITY Casino Management Limited ("**SCML**") applied for approval of a new floor plan, "2011 L3 003".
2. The plan shows the relocation of the two Black Jack tables from "the Nations Club Rooms" to the Poker Zone on level 3.
3. The application raises no issues the Commission needs to consider. Accordingly plan "2011 L3 003" is approved by the Chief Gambling Commissioner and the Executive Director under delegated authority, pursuant to condition 11 of SCML's operator's licence.
4. Plans "2011 L3 001" and "2011 L3 002" will become redundant once SCML is reliant on plan "2011 L3 003".

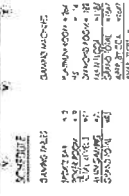
