

**DECISION UNDER DELEGATED AUTHORITY ON AN APPLICATION
BY SKYCITY HAMILTON LIMITED FOR APPROVAL OF
NEW SIGNAGE AT THE HAMILTON CASINO**


1. On 11 September 2020, SKYCITY Hamilton Limited (“**SHL**”) applied, pursuant to condition 6 of its venue licence, for approval to display signage on entry, internal and external screens, within outlets and as posters in various locations in and around the Hamilton casino.

2. Condition 6 provides as follows:

- 6. The Licence Holder must obtain the approval of the Commission prior to:
 - (a) ...
 - (b) ...
 - (c) the addition or alteration of signage relating to the casino business on the exterior of the casino venue or on or around the building within which it is located.

The process by which the Licence Holder may obtain approval for construction or design changes to Levels B1 and 1 of the Casino Venue (6(a) above) is set out in condition 7. The Commission will determine any application for approval under 6(b). The Executive Director may approve the addition or alteration of signage relating to the casino business on the exterior of the Casino Venue or on or around the building within which it is located (paragraph (c) above) if he/she is satisfied the proposed changes will have no potentially adverse effects. If he/she is not so satisfied, the proposed changes must be referred to the Commission for a decision on approval.

3. The proposed signage will have no potentially adverse effects and is approved by the Executive Director under delegated authority pursuant to condition 6 of SHL’s venue licence. A copy of the signage is **attached**.

To ensure the safety of our customers and the integrity and fairness of casino gaming, SkyCity operates CCTV surveillance cameras and body-worn cameras throughout its venues.

SkyCity reserves the right to search customers and their possessions on entry (including use of a handheld security wand) and deny entry to those customers who refuse to cooperate.

As part of our ongoing commitment to responsible gaming behaviour, SkyCity uses facial recognition technology within the casino. This technology is designed to detect individuals within the casino who are currently excluded from entering any SkyCity casino in New Zealand so as to enable SkyCity to meet its obligations under the Gambling Act 2003.

SkyCity does not permit loan transactions by third parties for financial gain at the casino venue. Any person found to be committing such an act will be excluded from the premises.

SkyCity management does not tolerate children who are loitering, or more specifically, left unattended on any part of its property and will take active steps to prevent this.
