

**DECISION UNDER DELEGATED AUTHORITY ON AN  
APPLICATION BY SKYCITY CASINO MANAGEMENT LIMITED FOR APPROVAL OF NEW  
FLOOR PLANS FOR THE AUCKLAND CASINO**

**Date of Decision:** 4 June 2021

1. On 3 June 2021, SKYCITY Casino Management Limited (“**SCML**”) applied, pursuant to condition 11 of its operator’s licence for the Auckland casino, for approval of two new floor plans, “2021 L2 003” and “2021 L6 001”.
2. Condition 11 of SCML’s operator’s licence for the Auckland casino provides as follows:
  11. The Licence Holder shall operate in accordance with approved floor layouts showing the position of gaming tables and gaming machines. The Licence Holder shall obtain approval for new floor plans prior to relocating or installing tables or machines in positions not specified in approved floor layouts. When applying, the Licence Holder must submit fresh plans showing the floor layout for the Gambling Area and details of the proposed CCTV layout for consideration. Any change must comply with the Surveillance Standard. The Executive Director and a single Gambling Commissioner may approve the new floor plans if they are satisfied that the floor layout has no potentially adverse effects. If they are not so satisfied, the proposed floor plan must be referred to the Commission for a decision on approval.

*Submissions*

3. SCML submitted as follows:

- (a) It is currently reliant on plans “2021 L2 002” and “2020 L6 001”.
- (b) The proposed new floor plans include the following changes:

Level 2

- Install 3 EGMs
- Remove 2 EGMs
- Remove 4 EGMs and reconfigure layout
- Remove 3 EGMs
- Remove 4 EGMs
- Change bank orientation
- Install 1 EGM and reconfigure layout
- Remove 1 EGM and change bank orientation

Level 6

- Reorientation of 1 EGM
- Remove 2 EGMs and reconfigure layouts

- (c) At all times the number of EGMs and gaming tables will comply with the requirements of its licence conditions. Changes to the CCTV layout will be implemented to ensure it remains compliant with the Surveillance Standard.

*Decision*

4. The Commission was satisfied that the proposed floor plans raise no issues of regulatory concern. Accordingly, plans "2021 L2 003" and "2021 L6 001" (**attached**) are approved by the Chief Gambling Commissioner and the Executive Director under delegated authority, pursuant to condition 11 of SCML's operator's licence, for the Auckland casino.
5. Once SCML is reliant on plan "2021 L2 003", plan "2021 L2 002" will cease to be valid.
6. Once SCML is reliant on plan "2021 L6 001", plan "2020 L6 001" will cease to be valid.

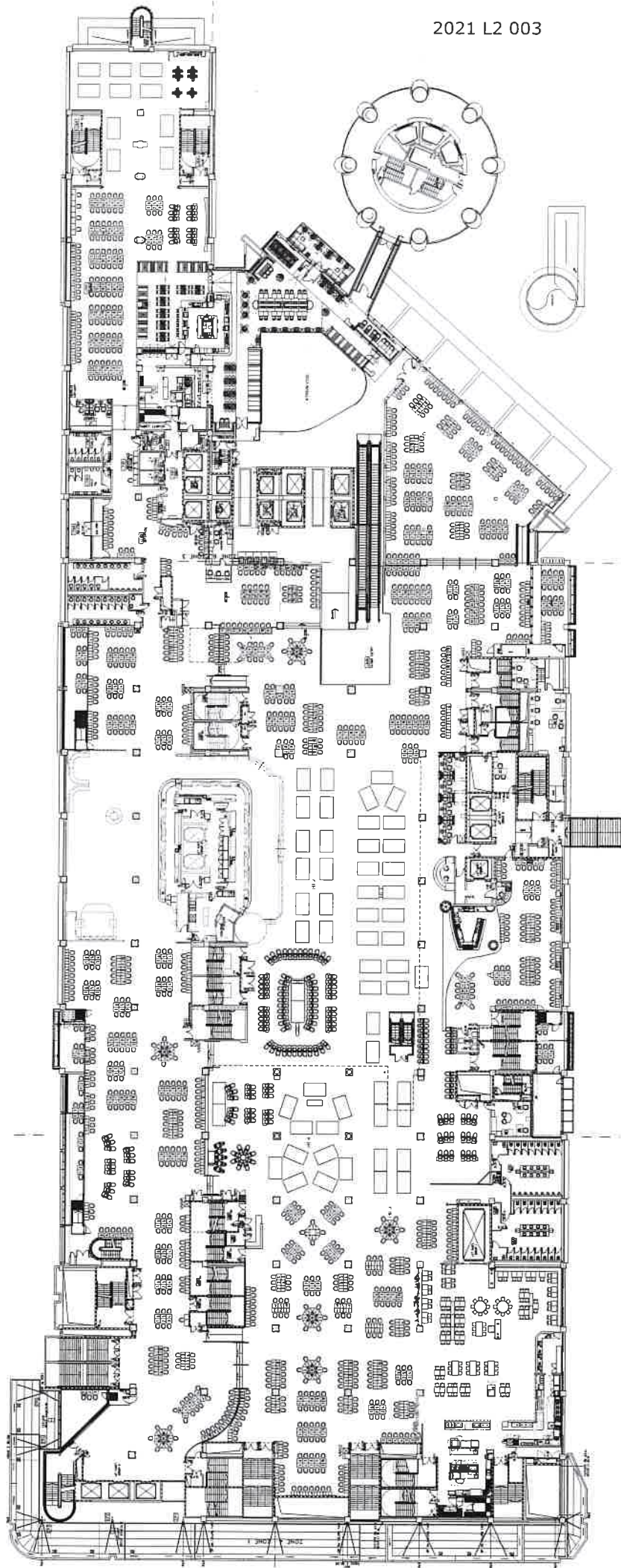


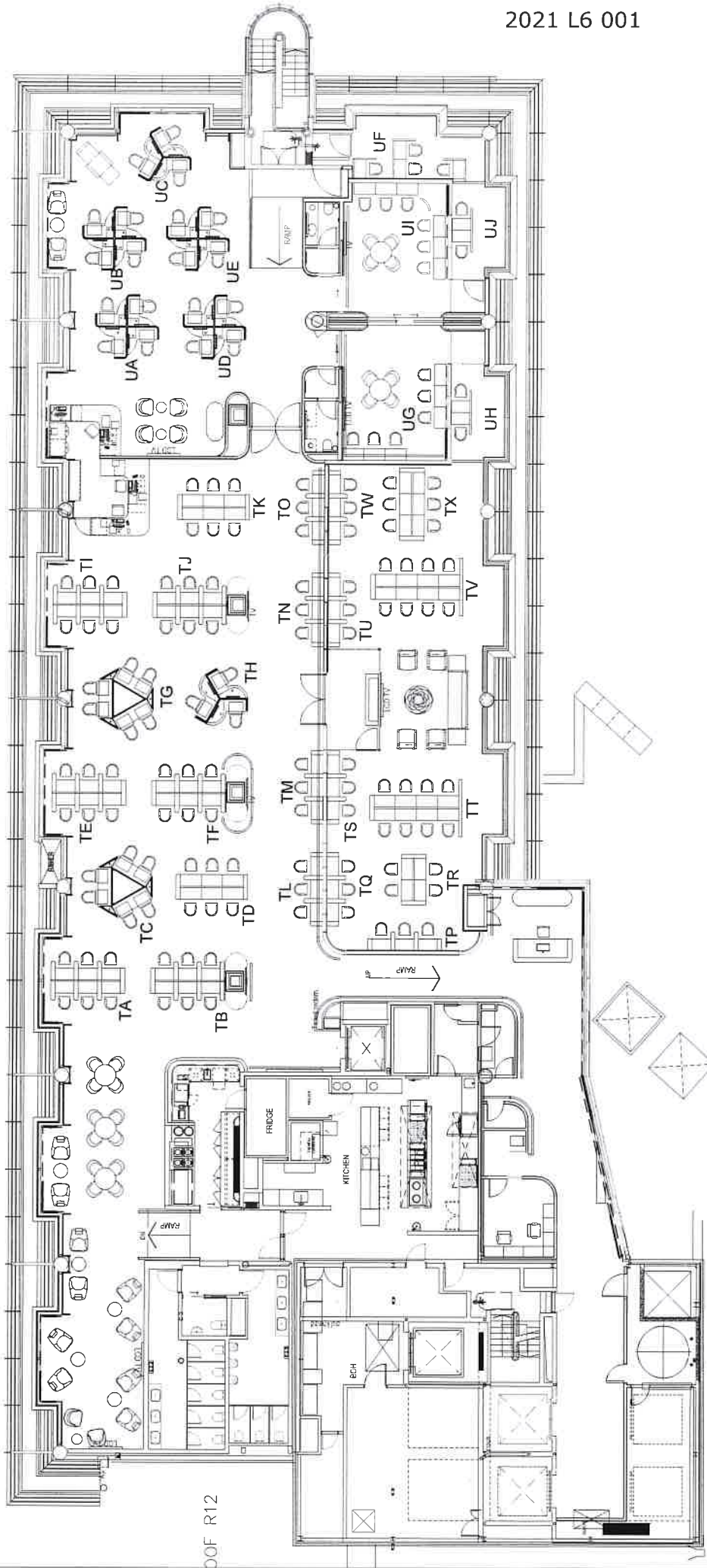
