

**DECISION UNDER DELEGATED AUTHORITY ON AN APPLICATION
BY DUNEDIN CASINOS MANAGEMENT LIMITED FOR APPROVAL OF A TEMPORARY
FLOOR PLAN AT THE GRAND CASINO DUNEDIN**

Date of Decision: 8 May 2025

1. On 7 May 2025, Dunedin Casinos Management Limited (“**DCML**”) applied, pursuant to condition 12 of its operator’s licence, for approval of a temporary floor plan, “Grand Casino Main Gaming Floor Plan Poker 2025” at the Grand Casino Dunedin.
2. Conditions 11 and 12 of DCML’s operator’s licence provides as follows:
 11. The Licence Holder shall operate in accordance with approved floor layouts showing the position of gaming tables and gaming machines.
 12. The Licence Holder shall obtain approval for new floor plans prior to relocating or installing tables or machines in positions not specified in approved floor layouts. When applying, the Licence Holder must submit fresh plans showing the floor layout for the Gambling Area and details of the proposed CCTV layout for consideration. Any change must comply with the Surveillance Standard. The Executive Director and a single Gambling Commissioner may approve the new floor plans if they are satisfied that the floor layout has no potentially adverse effects. If they are not so satisfied, the proposed floor plan must be referred to the Commission for a decision on approval.
6. DCML submitted as follows:
 - (a) It is hosting a poker tournament from 9 to 11 May 2025 and wants to make changes to its table configuration to facilitate this.
 - (b) On 12 May 2025, it will revert back to its current floor plan, “Grand Casino Main Gaming Floor Plan December 2023”.
 - (c) There will be no need to make any adjustments to the CCTV layout to accommodate the new floor plans – it will remain fully compliant with the Surveillance Standard.
 - (d) At no stage will the ratio of EGMs to gaming tables exceed 15.
7. The proposed floor plan raised no issues of regulatory concern for the Commission. Accordingly, plan “Grand Casino Main Gaming Floor Plan Poker 2025” (**attached**) is approved by the Chief Gambling Commissioner and the Executive Director under delegated authority pursuant to conditions 11 and 12 of DCML’s operator’s licence for the Dunedin Casino.

- 8. On 12 May 2025, DCML will revert to plan "Grand Casino Main Gaming Floor Plan December 2023" and plan "Grand Casino Main Gaming Floor Plan Poker 2025" will cease to have effect.
