**DECISION ON AN APPLICATION BY SKYCITY CASINO MANAGEMENT LIMITED
FOR APPROVAL OF A NEW GAME MIX ANNEX FOR THE AUCKLAND CASINO**

Introduction

1. SKYCITY Casino Management Limited ("**SCML**") applied to the Commission, under conditions 9 and 10 of SCML's operator's licence for the Auckland casino, for approval of a new game mix Annex. SCML wants to introduce Electronic Baccarat and Electronic Tai Sai to the currently approved game mix Annex, on the basis that these games were deployed interchangeably with an existing, approved electronic game, Electronic Roulette. As the games would use the terminals currently used for Electronic Roulette, the new games could be deployed immediately as no change to the currently approved floor plans would be required.
2. This application follows decision GC23/14, in which the Commission declined to approve a game mix annex which included Electronic Baccarat and Electronic Tai Sai until rules for those games had been finalised and gazetted. As the rules have now been finalised and gazetted, SCML now seeks approval of a game mix Annex which includes those games.

Licence conditions

3. The relevant licence conditions are as follows:



SCML's operator's licence (Auckland)

9. The Licence Holder may operate on casino gaming tables the game types and game mix(es) specified by the Commission in Annex A attached to this Licence. As an alternative to Annex A, the Licence Holder may operate on casino gaming tables the game types and game mix(es) specified by the Commission in any additional annex approved by the Commission and attached to this Licence. The Licence Holder must give the Inspectorate prior notification before it commences operation under a different annex. The game types and game mixes specified in an annex can only be changed by the Commission.
10. The approval of the Commission is required prior to the use by the operator of any electronic version of the game types specified in condition 9 above or electronic aids or enhancements or changes to table game rules which create new wagering opportunities.

SCML's submissions

4. SCML submitted, in summary, as follows:
 - (a) It has a game mix Annex for the Auckland casino, Annex A. This Annex provides for the operation of up to 4 Electronic Roulette games.
 - (b) The wagering period for an Electronic Roulette game has traditionally been configured to 30 seconds. In addition to the wagering period, historical data suggest that an additional 20.5 seconds is required to complete each round of the game. Thus, a round of Electronic Roulette takes, on average, 50.5 seconds to complete, which equates to 71.3 games per hour. This figure is very close to the 72 rounds per hour that resulted from SKYCITY's earlier 'lab' tests (on table game speed), and which has traditionally been used in submissions to the Commission identifying the theoretical rate of play for Electronic Roulette.
 - (c) The rules approved for Electronic Baccarat and Electronic Tai Sai include a fixed wagering period for both games to align their rate of play to that of Electronic Roulette. This should ensure that the new games have the same rate of play as that of Electronic Roulette. The DIA has indicated that it will review the relative speeds of these games once they are deployed on the floor and to the extent that any differences arise, further rule amendments may be needed to ensure appropriate alignment.
 - (d) The proposed revision to Annex A is designed to group and treat Electronic Roulette, Electronic Baccarat and Electronic Tai Sai as one game type. This is reflected in the notes for the alternative game mixes. Each game will have an identical number of player spaces (up to 30 terminals) and each is designed to operate at the same rate of play. Thus the gambling opportunities associated with each of the three game types are the same. The revised Annex A incorporates these changes.

- (e) A table is attached to its application which recognises that the rate of play associated with Electronic Roulette is the same as that used for Electronic Baccarat and Electronic Tai Sai.
- (f) The table confirms that the notional opportunities associated with each of the game mixes is less than those associated with the regulatory benchmark. It is satisfied that the revised Annex A will not increase casino gambling opportunities.

The Secretary's submissions

5. The Secretary submitted, in summary, as follows:

- (a) SCML has applied to introduce Electronic Baccarat and Electronic Tai Sai to its mix of games, and proposes that their introduction be facilitated by amending the designation of Electronic Roulette to incorporate Electronic Baccarat and Electronic Tai Sai. The rationale for this proposal is that the rate of play for the respective games should align.
- (b) He agreed with SCML's assessment that the rates of play between Electronic Roulette, Electronic Baccarat and Electronic Tai Sai should align. This outcome has been core to the DIA's harm minimisation considerations regarding these products. As noted by SCML, the DIA will review the relative speeds of these games once they are deployed to ensure the appropriate alignment of game speeds, in case unexpected differences arise. He does not anticipate that any differences would be significant or of a level that it would affect an assessment of opportunities for casino gambling.
- (c) The proposal to group electronic products in the game mixes represents a departure from the current approach (of having each table type individually noted in the game mix Annex). However, if SCML's approach is not taken, and each electronic table type is separately recorded in Annex A, the potential exists for a vast increase in the number of game mixes requiring approval and tracking. With this in mind, he does not object to SCML's proposed grouping.
- (d) However, since SCML's first application (which led to decision GC23/14), made before these game rules were gazetted, he became aware of moves in Australia to allow players at terminals of electronic games to switch between games. For example, a player playing Electronic Baccarat could switch to Electronic Roulette without leaving the terminal. As a result, he wrote to SCML seeking confirmation that it was not its intention to operate the games in this manner. The letter stated that, if this were SCML's intent, this type of issue would require further



consideration in a number of areas including Minimum Equipment Standards and Minimum Operating Standards.

- (e) SCML replied to the letter, stating that:

There are no immediate plans to move in this direction but it is something that we may wish to consider at some point. If and when we do, we will engage with [the Department] first to address implications around game standards, rules and other associated matters that may impact such an arrangement.

- (f) SCML does not appear to have made this application with the intent of allowing players to switch between games from the terminals. In order to have clarity on the issue, if this application is approved, an additional note for the alternate game mixes should be added, restricting each table to offering only one game at any given period when a table is open for play.

SCML's submissions in reply

6. SCML submitted, in reply, as follows:

- (a) For the purposes of this application, there is no intention to enable players to switch between the electronic suite of games specified. Footnote 1, which requires prior notification of any change to the game mix would prevent these games being used interchangeably by players.
- (b) However, if the Commission shares the Secretary's concerns that approving the new Annex A in the form proposed may provide scope for the interchangeable use of games, it would have no objection to a footnote which would prohibit such an approach, but without prejudice to any applications which it may submit at a later stage.
- (c) In principle it does not see a great deal of mischief in providing for such an arrangement, but will address that issue in more detail if and when it wishes to proceed down that path.

Analysis

7. As the Secretary has now finalised and approved the game rules for Electronic Baccarat and Electronic Tai Sai, SCML has sought Commission approval to include them in its approved game mixes and thus deploy these games.
8. The only change proposed by SCML for its game mix Annex is for Electronic Baccarat and Electronic Tai Sai to be introduced and deployed interchangeably with Electronic


Roulette. For the following reasons, the Commission is satisfied that the proposed game mixes would not increase opportunities for casino gambling:

- (a) the Commission has already determined that the existing game mixes with Electronic Roulette do not increase opportunities for casino gambling above those provided by the regulatory benchmark for the Auckland casino, game mix A;
 - (b) the game rules have been finalised in such a way that the speeds for Electronic Baccarat and Electronic Tai Sai are the same (or very close to the same) as Electronic Roulette; and
 - (c) the player spaces are limited in each case to the same number of terminals.
9. SCML's proposal does result in a variation to the traditional approach of listing each individual table game in the game mix Annex. However, as noted by the Secretary, if SCML were not to adopt the traditional approach, then the number of game mixes requiring Commission approval would increase dramatically, and the Annex would become unwieldy and difficult to monitor.
10. As the Secretary and his Inspectors (the people charged with overseeing gambling products on the gambling floor) considered SCML's approach to be more manageable, and as the suggested approach does not raise any other issues of regulatory concern, the Commission approved the three electronic table games being grouped together.
11. Finally, the Secretary suggested the inclusion of a Note which expressly forbids players from switching between different electronic table games. The Commission considered it prudent to insert this Note to require notification by the Licence Holder to the Secretary's Inspectors before switching between the three different electronic games which have been combined in the game mixes. If SCML, at some point in the future, seeks the flexibility for its patrons to switch between the various electronic table games, that will be a separate matter requiring consideration by the Commission, following submissions from the Secretary and possibly others on the resulting implications.



Decision

12. The Commission approved SCML's application, under conditions 9 and 10 of SCML's operator's licence for the Auckland casino, for approval of a new game mix Annex. A new Annex is **attached**.

Pursuant to condition 9 the following game mix may be operated by the Licence Holder on casino gaming tables, subject to the following conditions and requirements noted:

2. The Electronic Roulette table comprises up to 14 player spaces and no manual table.

Notes for the alternative game mixes:

1. The Licence Holder is permitted to change game mixes subject to providing the Inspectorate with prior notification.
2. The Licence Holder is permitted to operate automatic shufflers on each of the Black Jack, Caribbean Stud Poker, Baccarat, Poker, 3-Card Poker, Ultimate Texas Hold'em, Casino War and Lunar Poker tables.
3. At least 50% of the total number of Midi Baccarat games shall be conducted in accordance with dealing style B, as set out in the rules of Baccarat.
4. All Midi Baccarat games in salons 81, 82, 86 and 88 shall have 7 boxes only.
5. Electronic roulette tables comprise up to 30 player tables and no manual table.
6. Before switching between Electronic Roulette/Electronic Baccarat/Electronic Tai Sai, the Licence Holder must provide the Inspectorate with prior notification of the change.

7. Electronic Roulette (inc manual table) comprises up to 30 player terminals and wagers may be placed directly at the table.
8. The number of player spaces at Poker tables (other than Caribbean Stud Poker and 3-Card Poker) may not exceed 10, even if game rules provide for more.
