**NOTES**

4. A separate report is provided to show the companies associated with the individuals above. This report also acknowledges if a company has been removed and reason for removal with respect to the company going into receivership or liquidation. It should be noted that the removed/liquadated companies may not have been removed/liquidated during the time that the individuals were directors/shareholders.
5. There have been no complaints received, or investigations, regarding the individuals above, nor have we received complaints about the companies.
6. It appears that all compliance activities for the companies listed, such as filing annual returns, financial statements (where applicable) and updating company information has been adhered to as per the Companies Act 1993.
